What is Covered:

Dura-Bar warrants that its Dura-Bar product will be free from foundry defects.

What You Must Do:

You must examine the product on receipt and promptly notify us upon discovering any defect. In addition, you must provide Dura-Bar with sample parts or materials for our evaluation.

For How Long:

This guarantee only applies to defects discovered and reported to Dura-Bar within one (1) year from the date of delivery.

What We Will Do:

If a valid claim is made under this guarantee, Dura-Bar will (a) reimburse you for the actual direct labor cost incurred by you in machining the product prior to discovering the defect, provided that those costs do not exceed the purchase price of the defective product, and (b) either replace the product or refund the purchase price of the product to you (Dura-Bar will choose which of these actions to take).

Other Conditions:

This guarantee is the only warranty or guarantee that applies to our Dura-Bar product.
